Procedure

Disperse Xanthan Gum and Magnesium Aluminum Silicate in the blend water and Glycerin until obtain a homogenous blend. Add ARLACEL LC and heat to 75-80°C. Combine oil phase ingredients and heat to 75-80°C. When ARLACEL LC is melted, homogenize with an Ultra Turrax for 30s at 10,000rpm.
